Serious Youth Violence: What Practitioners Need to Know

The prevalence of Serious Youth Violence has increased across England and Wales since 2014, London is no exception to this, with increasing numbers of young people affected. Serious Youth Violence can be devastating for the individual, their family, friends, and the wider community. The survivors of violent injury can suffer lasting physical and psychological effects. The aim of this briefing is to provide information about Serious Youth Violence and the support available to young people who may be being affected in Hillingdon.

What is Serious Youth Violence (SYV)?

<u>Serious Youth Violence</u> includes the threat, and intentional use, of violence towards children under 18 years old. SYV usually occurs in a public place, it may or may not involve the use of weapons and can result in serious physical injury or death. Perpetrators may act alone, or as part of a group, SYV does not always happen in the context of gang activity. The intention of SYV is to cause significant injury, deprivation, psychological harm, or death.

Statistics evidence that young black boys are overrepresented as victims of peer homicide, but it is important to remember that any child can be a victim or perpetrator. Children may also experience loss, or fear, due to incidents involving their peers, or the wider community. Experience of prior victimisation can increase the likelihood of becoming a perpetrator for some children. A victim may feel they have been embarrassed or disrespected in front of peers and perceive a need to reassert their 'status'. Perpetrators of SYV may also be victims of exploitation in their own right; they could be being pressured or threatened or in debt to drug dealers. SYV can also stem from disputes related to gang activity, drugs and territory. Exclusion from mainstream education is known to be a risk factor for involvement in Serious Youth Violence.

Everyone has a role to play in reducing the harm caused through Serious Youth Violence.

Be curious about the information you are being told by the child and/or their care giver.

Do not always take what you are told as fact, be uncertain.

Protect children from SYV without fear of a breakdown in your relationship.

View a referral to children's social care as the start of an exploration,

not an accusation.

Be prepared to talk about your observations of injuries and worries.

If the child is willing to talk, give them time and space.

'Walk in the child's shoes'

Consider the situation from their lived experience (have empathy).

Be patient, ask open questions in a non-judgemental way that is focused on the safety of the child.

It is okay to be unsure about what to do, If you are concerned <u>seek</u> <u>advice</u>

- Is there more than one person making you feel unsafe or afraid?
- Who is making you feel unsafe? How do you know them?
- Have they threatened to hurt you or anyone else you care about (including animals, property)?
- Is there someone else that knows about what is happening to you or you have talked to?
- Have they physically hurt you in any way? (Hitting, choked, kicked, strangled, poisoned)
- Do they have access to materials/weapons to carry out their threats?
- Do you feel safe to leave here today?
- Do they know where you live or what personal information do they know about you?

When a child experiences a crisis, perhaps witnessing or being a victim of violence, school exclusion, or being arrested there is an opportunity to intervene; known as a **'teachable' or 'critical' moment**. This is the time when a child will be more receptive to the idea of change. The <u>words used</u> and actions taken by professionals are more likely to reach the child and influence the child to change direction if they need to. The <u>language used</u> to describe children also affects how we understand risk e.g. 'boys' and 'girls' not 'males' and 'females'. **Think about the child** behind the behaviour.

What to do if you are concerned:

- Speak to your Agency Safeguarding Lead
- If you have concerns about a child's welfare complete a Stronger Families Assessment and submit through the Stronger Families Hub to access support
- If you are concerned a child has, or is likely to, suffer harm call: 01895 556 006 for advice
- If a child is in immediate danger, please call the **Police**.
